

Companies involved in the consigning, transport and physical loading of dangerous goods beyond legally defined thresholds are required to appoint a Dangerous Goods Safety Advisor (DGSA) to guide them on the legal, safety and environmental aspects. This may apply to AIC members and trade assurance participants in feed, fertiliser and crop protection sectors.

DGSAs hold a qualification in specific types of transport, for example, road transport.

The AIC DGSA Register is a benefit to AIC members and Trade Assurance Participants as it aids finding and contacting a DGSA within a local area, with relevant specialist skills.

Note that under ADR 2019, the requirement to appoint a DGSA is now extended to companies who act as consignors of dangerous goods including office-based consignors. Following a transitional period, this requirement is implemented from **1 January 2023**.
