2019 Standard

Merged into single Standard

Re-ordered requirements

- More logical
- Style similar to UFAS

Production and Gatekeeping in one standard

- Will also include Scheme Rules
- Sector Notes will remain separate

Format of Standard

Split into lettered sections

 Each requirement individually numbered

Guidance below requirements where necessary

• In *Italics*

G6 Pest Control

- G 6.1 The participant must nominate an employee responsible for the management of effective pest control systems.
- *Guidance* Pest control activities may be carried out by employees of the participant, or by a professional 3rd party contractor.
- G 6.2 Risk assessment methods must be used to identify potential problems from the presence of pests.
- Guidance Animals which are present and could contaminate feed should be considered pests for the purposes of this section.
- G 6.3 A pest control plan must cover:
 - the control of pests
 - regular inspection of all the <u>premises</u> at predetermined intervals
 - monitoring of stored goods
 - Identification of bait station locations
 - types of treatments to be used
- G 6.4 Results of inspections must be recorded

• Hyperlinks cross reference within Standard

Key to interpreting the Standard

- When supplier certification is needed
- What constitutes Gatekeeping





Definitions - Feed

Defined as: Any substance or product, including additives, whether processed, partially processed or unprocessed, intended to be used for oral feeding to animals

• Referred to throughout standard, unless more specific description needed, e.g.

Feed additive

Feed Ingredient

Feed Material





Definitions - Raw materials

Defined as: All materials used by participants for manufacturing, processing or blending into feed

Not necessarily "feed" (yet)

• May require processing

If not legal for use as feed without processing:

- No need for certified transport, storage
- But must be safe and fit for purpose





Definitions - Gatekeeper

Defined as: A participant who sources <u>a feed</u> from a supplier not assured against a scheme recognised by AIC and takes responsibility for the safety and suitability of the feed before it enters into the assured supply chain

- Gatekeeping only possible if material is already a feed
- If not, it is outside the scope of FEMAS

Gatekeeper carries out no processing (including packing/ repacking)

• If processing is carried, out participant is sourcing a raw material

Retain requirement for case by case approval





Sector Notes

Full set of Sector Notes

• Will be implemented at the same time as FEMAS Standard

Re-ordered to match new format

Consultation with sectors to ensure fit for purpose





Single document

- All the information in one place
- Better coordination between Production and Gatekeeper requirements

Clarity

- Comprehensive definitions
- Format distinguishes between requirements and guidance

Convergence

- Order of requirements *similar* to UFAS
- Writing style in keeping with UFAS
