If you are a TASCC Participant and interested in joining our Working Groups and Review Groups, please contact gill.barrow@agindustries.org.uk. The TASCC and Transport Working Groups each meet three times a year, one meeting is in person and the Testing Working Group meets twice a year virtually.

The purpose of the Working Groups is ensuring the robustness of the scheme, ensuring it is up to date, and includes stakeholders within the supply chain. Anyone involved in the day-to-day compliance with TASCC who would like to be involved in the scheme's development can join one of the Review Groups. TASCC is continually reviewed, and it is essential to have industry representation ensuring it is fit for purpose and maintains food and feed safety.

Do you have what it takes to be an auditor?

TASCC certified hire trailer companies

In April 2022 it became a requirement for trailer hire companies to be TASCC certified.

The certified companies and their TASCC reference number are listed below. Trailers which are hired from a non-certified business will result in a non-conformance being raised during your audit.

TASCC vehicle identification tip

Section H7 in the Haulage Code of Practice details how and where vehicles must be identified and, H7.2.f specifies that the size of identification must be no smaller than the size of lettering on number plates.

Non-conformances are being raised where the identification is not meeting the requirement.



Purchasing of second-hand vehicles/trailers

When purchasing a second-hand vehicle/trailer you must gain approval from the Certification Body.

In order for approval to be given, as a minimum the following is required:

- a signed declaration confirming the trailer has not carried any forbidden/exclusion list material
- details of the past three loads
- the cleaning and sanitising records
- VIN/chassis number
- date of acquisition

The above are requirements of clause H8.1.d. Without this information, approval cannot be given and therefore the vehicle/trailer will not be allowed into the TASCC Scheme.

Kiwa maintains records of all vehicles that are, or have been, TASCC certified vehicles/trailers.



Earned recognition – what does it mean?

TASCC has 'earned recognition' with UK Government which means TASCC-compliant businesses have a lower risk rating.

Earned recognition with the Food Standards Agency (FSA) in England and Wales, Food Standards Scotland (FSS), and DAERA/FSA Northern Ireland means that AIC has a close working relationship with the authorities and a legal basis on which to share information relating to industry compliance and potential food/feed safety issues.

Recognition of the scheme is maintained by monthly, quarterly, and annual submission of scheme data, working closely with the Certification Body and ensuring the scheme meets legislative requirements.

For TASCC Participants, the key benefit is being certified to a recognised scheme and maintaining a consistent level of compliance which reduces the frequency of official visits to your business from enforcement officers.

Mutual recognition refers to schemes that recognise one another, and therefore any certified Participants to that scheme are suppliers of safe food/feed.

TASCC audit advice

It is a requirement of TASCC clause G9.1.b to review all relevant food/feed legislation at least every 12 months and document the review.

It is recommended to include this when carrying out your annual management review to ensure the business remains up to date with regulatory requirements.
