Driver welfare facilities

Covid-19 affected the haulage industry in many ways – many drivers were furloughed along with the testing backlog and difficulties of visiting sites at the height of the pandemic due to strict rules and protocols.

One area of initial concern was the lack of provision or access to welfare facilities for visiting drivers. We have seen very positive steps taken across the sector to provide and manage such facilities throughout the pandemic. It is particularly important that we build on this good work in order to attract people into the haulage sector. Hired Trailers

As of 1st April, it is now a requirement to hire rigid vehicles and trailers from a TASCC certified company. As per the Haulage Code of Practice, you are still required to uniquely identify the trailer with numbers or letters and with your Scheme ID on both sides and rear of the vehicle. The hire company will label the trailer on the front.



AIC Academy


AIC has brought together all its training resources for AIC Members, trade assurance scheme participants, and feed advisers under the banner of "AIC Academy".

Joint Scheme Development Project

In December 2020, a group was formed to jointly develop a common set of requirements and wording for the FEMAS, TASCC, and UFAS schemes. The committee is made up of industry representatives from each scheme; this will assist participants who are certified to multiple schemes whilst maintaining consistency of requirements. The revised schemes will launch in the first half of 2024.



TASCC short notice audits

AIC planned to introduce short notice audits in 2020 in response to market demands from customers and stakeholders. This was postponed due to the pandemic and remote auditing. The short notice programme has been reinstated since returning to on-site audits.
