Driver Shortages

The well-publicised shortage of HGV drivers is challenging many parts of the agricultural supply sector, in multiple ways. This is a culmination of several issues that have arisen over the past 18 months, including Covid-19, post-Brexit trade friction, overseas drivers leaving the UK, an ageing (and retiring) workforce, and thousands of cancelled HGV tests.

The agri-supply sector relies on trained drivers to ensure that food hygiene, feed safety, and animal health requirements can be met, as well as dealing with seasonal variation related to harvest and the annual sugar beet campaign. Add to this the ongoing issues with fuel deliveries, and it is inevitable that several businesses have been unable to make collections from or deliveries to farms.

AIC is lobbying Government to take further steps in supporting the agri-supply sector. As things stand, it is very unlikely that current difficulties will improve as we head into winter and 2022.

Remote audit update

TASCC participants have adapted well to virtual working, with remote audits ensuring that feed and food safety has been maintained. The embracing of technology, and cooperation of both participants and auditors is highly valued, which has ensured that feed and food safety has been maintained.

We are phasing in physical audits during autumn. AIC will continue to update participants via Member Briefings regarding the remote auditing process and when a physical onsite audit becomes the default.



New AHDB training modules for analysts

Grain analysts can take advantage of new modules for oats and rye testing, from AHDB. The new modules are available alongside other topics including mycotoxins, barley screenings, peas and beans, and more, all written by industry experts. 


Testing - No major non-conformances within reporting period.

Forbidden/Exclusion List Materials

Scheme participants are reminded that any TASCC certified trailer found to be carrying forbidden/exclusion list materials will be removed from the TASCC scheme. As such, it's important to ensure your knowledge in this area is current and correct, and ask for clarification if you are unsure.

Some product names still cause confusion. Fibrophos (produced using fly ash from animal incinerators) may be carried in TASCC certified trailers. However, Fibrophos from the Thetford plant remains on the exclusion list and must not be carried. P-Grow, Kalfos and Tigerfert (all fly and bottom ash mixtures) products also remain on the forbidden/exclusion list and must not be carried in TASCC trailers.

If you are in any doubt about whether a material can be carried please contact AIC or Kiwa for clarification, ideally with a Product Specification Sheet detailing the product details, its content and source.
