Joint Scheme development

The UFAS, TASCC and FEMAS Standards were thoroughly reviewed, aligning clause requirements across the schemes to ensure consistent wording. Following the implementation of the schemes in October 2024, the review process begun again, primarily focusing on haulage and storage. We expect to publish a draft version of the new standards for public consultation in May/June 2026, with audits to the new standards beginning on 1 October 2027.

Sheeting loads at all times

It is a requirement of the TASCC Standard that vehicles must be sheeted at all times except when loading/unloading or if sampling is taking place as per clause H12.1. An un-sheeted loose load in a bulk tipper is a DVSA vehicle defect category and is subject to an immediate prohibition.

Ensure you are set up to receive the assurance alerts regarding the certification status of scheme Participants.

AIC launches new Trade Assurance Checker App

AIC's Trade Assurance Checker app is now available as a free download for iOS and Android devices. Fully synchronised with AIC's existing Trade Assurance Checker on the website, the app brings greater accessibility and convenience, allowing the status of a supplier to be checked anywhere. The app enables searches by trade assurance scheme, FEMAS, TASCC, UFAS, FIAS, RED, and ESTA, and Participant status, including certified, suspended, applied, and withdrawn companies.

AHDB Grain Analyst Training - Ergot Module

The suite of training modules available on the AHDB website has been reviewed in line with the revised TASCC 2024 Testing Standard and legislation changes. The revised G09.5 ergot module has had some important changes made and the test has been reset. It is an auditable requirement for those testing for Ergot to re-take this module.

Assured Supplier approval

Clause M3.2.a in the Merchants TASCC Standard has been updated to state, "a system must be in place to verify the current assurance status of the suppliers when entering and executing a contract or agreement."


Participants may need to use a variety of methods to check the continued assurance status of their suppliers and the schemes they are certified under. For example, if a supplier is also a Participant of an AIC scheme, it may be sufficient to use the Trade Assurance Checker when entering a new contract. Then ensure the relevant personnel receive Assurance Alert emails to stay updated on any changes. Some other schemes also offer email alerts; if not, you will need to check their schemes websites.

Maintaining an up-to-date Vehicle Inventory is a scheme requirement. Please ensure it accurately represents your fleet by removing trailers no longer in use and seeking approval for new, hired or secondhand vehicles.

Did you know?

Kiwa, the certification body, is also subject to annual witness assessments by the United Kingdom Accreditation Service (UKAS). These assessments ensure compliance with the accreditation requirements of ISO/ IEC 17065:2012.

During a TASCC audit, UKAS evaluates how the auditor conducts the audit, their industry knowledge, and their interactions with personnel. They also ensure that all areas of the scheme are audited to meet TASCC requirements. Witness assessments are conducted for each AIC scheme and include an assessment at Kiwa's head office.



Trailer clean out guide

Maintaining trailer hygiene is essential for meeting assurance scheme requirements and ensuring the safety of food and feed. This document gives guidance, in conjunction with operators' own safe system of work policy, for all stakeholders to collaborate effectively.
