Digital Membership Cards

As part of the ongoing development of FAR, AIC Services has developed a digital Feed Adviser Card to replace the plastic cards currently used by Feed Advisers. This is a major digital transformation project for FAR, which will be integrated with the FAR database and accessible via Apple and Google Wallets.

What's on the card

- Digital wallet cards display the Adviser's name, membership number, type and validity.
- QR codes link to a validation page showing the Adviser's membership status and areas of specialism.

The digital membership cards have been tested by Members of the FAR Working Group, and all FAR Members will be contacted with details of how to install the card on their devices. Once installed on individual devices, users can scan the QR code associated with their card to view their FAR details, including their current FAR membership status. This status reflects whether the Adviser is actively registered and compliant with the scheme's professional standards.

EUDR & UKFRC update

Recently, AIC hosted an insightful webinar focusing on the UK Forest Risk Commodity Regulation (UKFRC) and EU Deforestation Regulation (EUDR). The event, led by Ed Barker, AIC Head of Policy, and James McCulloch, Feed Sector Head, provided valuable updates and guidance on these critical regulations.

The webinar covered:

- An overview of the EUDR, which is due to be implemented on 30 December 2025 and, significantly, will apply in Northern Ireland.
- The scope of EUDR, covering various commodities such as beef, cocoa, coffee, palm oil, rubber, soya, and wood, and an update on the recently published delegated act and amendments to Annex I of Regulation (EU) 2023/1115.
- An overview of the UKFRC and its focus on enhancing supply chain management and sustainability.

Despite initial hopes of an exemption, the EU Commission has now made it clear that palm kernel expeller (PKE) and palm fatty acid distillate (PFAD) will remain in scope.

The most significant clarification from the EU Commission is that compound feed is not in scope, meaning that UK suppliers of beef to the EU are not legally required to provide any information on the deforestation status of compound feed that may have been fed to animals supplying the beef.

AIC has been attending a number of industry and stakeholder events to inform groups of recent regulatory and supply chain developments. A set of FAQs is regularly updated on the Feed Sector page of AIC's website.


Update on the GB Register of Feed Additives

The UK Food Standards Agency (FSA) published an updated register of feed additives in Great Britain on 1 April 2025, following the implementation of The Food and Feed (Regulated Products) (Amendment, Revocation, Consequential and Transitional Provision) Regulations 2025. This update has resulted in a large number of feed additives no longer being listed on the Register.

AIC, the British Association of Feed Supplement and Additive Manufacturers (BAFSAM), the British Equestrian Trade Association (BETA), and UK Pet Food are working closely with the FSA to understand the rationale behind the changes and to highlight the implications for the feed industry.

The four feed associations held a constructive meeting with the FSA Feed Policy Team, and the FSA is keeping all parties updated on work underway to reinstate certain additives and to review the status of others.

AIC will provide briefings to Members as and when the Register is updated by the FSA. In the meantime, our advice is to review the Register and contact James McCulloch at james.mcculloch@agindustries.org.uk if you identify any additives that have been removed from the Register and that you consider to be in use and critical to the feed industry.

Sustainability of Game Feed module launched in July



Building on the livestock sustainability training released in 2023, this year's Continuing Professional Development (CPD) module for game feed advisers focuses on calculating the carbon footprint of feed materials and products, sector-specific sustainable feed principles, responsible sourcing of raw materials, and feeding management through formulation and the use of additives to optimise efficiency.



AHDB pig and poultry emissions calculator

From January 2025, all permitted pig and poultry farms were required to report their nitrogen (N) and phosphorus (P) excretion levels annually. Since 2022, this has been a requirement for permitted farms within the Wye Valley catchment.

Permissible levels of N and P excreted per animal place are specified, and all farms must comply with these limits.

This aligns with the Environment Agency's (EA) efforts to promote sustainable farming practices and ensure compliance with environmental standards. The National Farmers Union (NFU), in partnership with the EA and industry trade bodies, has developed a new mass balance reporting tool for farmers to calculate excretion levels across different poultry production systems.

N and P reporting is not required for pullets, breeders, and quails, and P reporting is not required for ducks.

The calculator tool is available on the Agriculture and Horticulture Development Board (AHDB) website.
