The New FIAS Standard

- Version 5, April 2021

The FIAS Standard review is now complete culminating in a new Standard: version 5, which was published in November 2020. It has now been submitted to UKAS for final approval.

The new Standard will be implemented from 1st April 2021, a later date than originally planned to allow adequate time to secure UKAS approval and for Kiwa Agri Food to obtain accreditation against the new Standard. The next issue of the TASCC Code of Practice will be on the same date to facilitate joint audits.

The basic requirements of the FIAS Standard remain unchanged – to ensure the legality, safety, security and traceability of fertilisers throughout the supply chain.

Some key changes include:

- Business process risk assessment: the name has been changed to highlight the need for risk assessment at every stage of fertiliser handling across a business.
- Training: at least one designated person from the business is required to have completed the relevant FIAS i-learning module or equivalent training.
- Derogation for non-FIAS contractors and merchants: this has been clarified and the process for approval written in more detail.
- Online sale of fertilisers referenced.

FIAS Standard Version 5 Questions

Where can I see the new version of the FIAS Standard?

This is available on the AIC FIAS website.

What's changed in the new version?

Some changes have been highlighted in this FIAS Update (page 1) but you can also access a detailed document that fully summarises the changes on the AIC FIAS website.

One of the more noticeable changes is that the four existing Standards for manufacturers, merchants, transport and storage as well as the scheme rules, have been brought together into one document. Each section is colourcoded to make it easy to find the relevant sections for your business.

The online version of the Standard contains links to external reference sites for legislation and guidance documents. It also benefits from navigational links within the Standard itself as well as linking to useful information such as key definitions and contact details.

Why change the format to one document?

Having all the Standards in one document demonstrates that FIAS applies to the whole fertiliser supply chain; from sourcing materials through transportation to delivery to the end user. The scheme rules and the general section apply to all FIAS participants and these make up the main body of the Standard followed by specific sections for each business type.

Can I get a printed copy of the Standard?

When will auditing to the new Standard start?

The new Standard will be audited and implemented directly from the 1st April 2021 with no 3 month observation period.

What support is there to prepare for the new Standard coming in?

AIC and Kiwa Agri Food will provide information and support to ensure participants are aware of the changes. The AIC FIAS web page will be updated with additional guidance, templates and checklists.

Auditors will also have training on the new Standard. This forms part of the UKAS accreditation of Kiwa Agri Food as the certification body for FIAS.

The FIAS i-learning modules for drivers, transport managers, stores and merchants will undergo revision to ensure they match new Standard requirements.

Lessons from Beirut

The devastating explosion in Beirut in August 2020 served as a painful reminder for everyone who handles fertilisers, such as ammonium nitrate (AN), of their potential destructive power if not stored safely or handled correctly.

As the world learnt more about the events that led up to the explosion, media outlets in the UK had questions and AIC Fertiliser Sector Head Jo Gilbertson was able to represent the UK fertiliser industry in explaining how the Beirut explosion happened as well as providing assurances that the same thing could not happen in th UK.

Robust safety regulations

The UK and Europe have many controls and regulations in place regarding ammonium nitrate and other hazardous materials including:

- COMAH (Control of Major Accident Hazards).
- ALARP (as low as reasonably possible) risk assessments.
- Legal requirements for positive release testing on every batch of fertiliser made to test the material's resistance to detonation.

All of these controls have been developed for safety and security to prevent tragic accidents or terrorist acts. The UK and Europe fertiliser industry takes its responsibility for stewardship of this material very seriously. FIAS provides a means to ensure the supply chain is in compliance with all controls and regulations through regular auditing.

What went wrong in Beirut?

The stored ammonium nitrate in Beirut had not been handled correctly and may have been contaminated, therefore making it unstable. The resulting explosion in Beirut sadly demonstrates what can happen when safety procedures are not followed and complacency creeps in.

FIAS participants have a key role in ensuring a robust, safe



How have we responded?

Following the Beirut incident, the FIAS committees and stakeholders are looking to confirm the robustness of FIAS and provide additional guidance including a new checklist:

AIC Ammonium Nitrate Fertiliser Safety Checklist, based on the AIC Guide: The Storage, Handling and Transportation of Ammonium Nitrate-Based Fertilisers 2015.

The checklist is intended to support all production sites, stores and warehouses where AN-based fertilisers are handled and allows a business to check that it is following relevant legislation and good practice.

Successful Remote Auditing

As COVID-19 continues to affect all of our lives, AIC Services would like to thank our FIAS participants and certification body, Kiwa Agri Food, for the determination and energy that has gone in to continuing the FIAS auditing program. With the dedication of all involved, we have been able to maintain FIAS Standards whilst protecting auditors and participants from COVID-19.

The auditing process has seen several changes over the year and although challenging at times, these have been accepted and put into practice with very few issues. For example, the uploading of documentation via the portal system prior to audits has shortened the amount of time people needed to be on site as well as allowing the focus to be on key points.

AIC Services will continue to review the situation as the pandemic progresses. Some of the changes that were necessitated by the pandemic, have been received positively and looking to the future we will look to include remote auditing and the use of technology as additional tools become available to us. Whilst not suitable for all circumstances, a blended approach with physical site audits may be possible.


